FORM OF PROXY

This proxy is solicited on behalf of Manulife Investment Management Limited ("MIML"), the manager of the mutual funds listed below.

SPECIAL MEETING OF SECURITYHOLDERS OF

Manulife Global All Cap Focused Fund Manulife Global Thematic Opportunities Fund Manulife Global Thematic Opportunities Class (each, a "Fund" and, together, the "Funds")

Details of the matters to be voted on at the Special Meetings (as defined below) are set out in the Management Information Circular accompanying the Notice of Special Meetings. Unless directed herein to the contrary, this proxy, if executed in favour of the management nominees, will be voted FOR the resolutions herein. If any amendments or variations to matters identified in the Notice of Special Meetings are proposed at a Special Meeting or if any other matters should properly come before a Special Meeting, this proxy confers discretionary authority to vote on such amendments, variations or other matters according to the best judgment of the person voting this proxy at the Special Meeting. Any proxy previously given by the undersigned securityholder in respect of the Special Meetings is hereby revoked. This form of proxy must be executed by the securityholder or an attorney authorized in writing or, if the securityholder is a corporation, under its corporate seal or by an officer or attorney thereof duly authorized. The signature should correspond with the name imprinted hereon. Where two or more persons are named, all should sign. If this proxy is not dated in the space below, it shall be deemed to bear the date on which it was mailed by management.

A securityholder has the right to appoint a person (who need not be a securityholder) to represent him/her at a Special Meeting and may do so either by inserting the other person's name in the space provided below and striking out the names of the management nominees or by completing another form of proxy.

A securityholder or the proxy nominee may only vote in respect of those Funds in which the securityholder holds securities as of the close of business on Thursday, March 6, 2025. To simplify this process for you, this customized proxy includes only those questions that relate to one or more of the Funds held by you as at the close of business on March 6, 2025. In the case of a conflict between the records of MIML, the registrar and transfer agent of the Funds, and this form of proxy as to the securities of a securityholder, the Funds shall rely solely on the records of MIML as to ownership of securities.

To be valid, forms of proxy must be received at Data Processing Centre, P.O. Box 3700, Stn Industrial Park, Markham, Ontario L3R 9Z9 **no later than 10:00 a.m.** (**Toronto time**) **on Tuesday, April 15, 2025** or not later than 24 hours (excluding Saturdays, Sundays and holidays) prior to the commencement of any adjourned or postponed Special Meeting, or with the Chair of the Special Meeting prior to commencement of the Special Meeting.

Please remember to vote the securities and read the relevant resolutions that are referenced on the reverse of this form of proxy.

YOUR VOTING INSTRUCTIONS

You hold securities of the Fund(s) listed. The full text of the resolutions is set out in the Management Information Circular. Please check "for" or "against" in respect of the Fund(s) in which you own securities.

VOTE BY MAIL: To vote by mail from anywhere in the world: 1. Complete this form. 2. Sign and return the form in the enclosed envelope.

VOTE BY TELEPHONE: *To vote by telephone from anywhere in North America:* you may enter your vote instruction by telephone at 1-800-474-7493 (English) or 1-800-474-7501 (French). Your 16-digit control number is located across from the Fund. You cannot use the telephone voting service on the day of the Meeting.

VOTE BY INTERNET: To vote by internet from anywhere in the world, visit www.proxyvote.com. Your 16-digit control number to access the internet voting system is located across from the Fund. You cannot use the internet voting service to vote on the day of the Meeting.
